# Re: Changes in the procedure of Reviewing Statements of children and young people

The Welsh Government is currently transforming expectations, experiences and outcomes for Additional Learning Needs children and young people. One aspect of this is the legislation – Additional Learning Needs and Education Tribunal (Wales) Bill that is about to be presented to the Welsh Assembly Government before Christmas 2016. Gwynedd Council and Isle of Anglesey Council have been innovative in creating a new Strategy that ties in with the changes introduced at a national level to **locally review the systems** for Additional Learning Needs and Inclusion.

## What will change?

One obvious aspect of the changes is that SEN Statements will be replaced by new Individual Development Plans (IDP) – but that will have **the same legal enforcement.** To create an IDP, a process called Person Centred Planning will be used.

This year, when preparing for the changes, Gwynedd Council and Isle of Anglesey Council are to **review each Statement using person centred methods.** The **enclosed handouts** describe what person centred planning is, as well as how the Review will be held using this method.

### When will this happen?

If your child is in a transitional phase (i.e. year 6 or year 9), the school should already have contacted you to arrange your child's Review during this term.

If your child is not in any of these years, a specific time-table will be set out for the Reviews and your school will contact you with the details. Through joint arrangements with the schools, the Authority's ALN services representatives will attend the meetings and reconcile the review method using a person centred approach.

#### What will this involve?

The Review meeting may last about an hour and we will discuss and plan for the coming year, and will be more informal compared to previous statement reviews of your child.

We will **ask you to choose** whether you are happy for your child to receive the support via the IDP only, (terminating the Statement) **OR** continue with the Statement and IDP for a period. Please note if you do decide to terminate the Statement this would not have any impact on the level of support that your child receives – as the same Criteria will apply.

The information that is gathered at the meeting will be considered (in the usual manner) by the Moderation Panel so as to ensure that any arrangements that your child requires are made. In an instance where you as parents are unhappy with the Moderation Panel's decision, arrangements will be made that will enable you to appeal.

#### What about our statutory rights?

This does not prevent your **right to appeal** to the **Wales Special Needs Tribunal** within two months of receipt of the Individual Development Plan or Statement (TAAAC, Government Buildings, East Spa Road, Llandrindod, Powys, LD1 5HA; 01597 829800)
